Riki Kolbl-Nelson grew up near Salzburg, Austria and came to the U.S. as a young adult. She has bachelor's and master's degrees in English from the University of North Carolina, Chapel Hill, a B.A. in art from St. Olaf, and a master's of fine arts from the University of Minnesota.

She has worked as an artist and poet for several decades, giving workshops and teaching classes as well as exhibiting her own art here and abroad. She co-founded a local poetry writing and critique group and has had several books of poetry published. Kolbl-Nelson has taught adult education art classes at St. Olaf and in the art department honors program at the University of Minnesota, as well as classes at Elder hostels and the local Elder Collegium. She has works on exhibit at the Northfield City Hall and at Print and Graphic on Bridge Square.

The February board meeting was called to order by Kathy Larson, president, at 1:00, at The Coffee Shop. The following were in attendance: Kathy Larson, Karen Rasmussen, Pat Fuchs, Pauline Schreiber, Mary Lillguist, Pat Rice, Emily Nesvold, Diane Hagen, and Gloria Carter.

Kathy Larson shared that today is the 90th anniversary of our AAUW branch. We shared in an anniversary treat provided by Kathy. A group picture was taken. The national office sent a congratulatory email regarding our 90 years of empowering women. Kathy sent a thank you to the national office. We are to receive documentation of our anniversary.

We are to submit the names of our state convention delegates and register for the convention by March 13th. The Convention is April 10th and 11th, in Austin, MN. The registration form and schedule can be found in the Pine. We can have four delegates based on our membership of 39. We traditionally send, at a minimum, the co-presidents and the Funds chairman, and then vote on

Gloria Carter seconded the motion. The motion carried. We want to strongly encourage as many members as possible to attend the convention, even if it's just for one day. We hope we can interest some of our newer members to attend and experience AAUW on the state level and hopefully reimburse some of their expense. Attendees are to submit and pay for their own registrations by the March 13 deadline. The co-presidents will contact newer members to encourage attendance.

Pat Rice shared information about the "baskets" or our stuffed AAUW Book bags we will donate for the LAF Silent Auction at the convention. Pat has started pulling books for inclusion. Please bring articles to include in the baskets to Pat, or bring to our next branch meeting. Suggested articles include coffee, tea, wine and wine rings, pedometer, socks, candles, cocoa, popcorn and salts, candies, coffee mugs, etc.

April 25th is the date for the Tri-Branch Luncheon in Northfield this year to be held at the Northfield Senior Center, (1651 Jefferson Parkway, Room 103). We are holding The Kids Karnival at our book sale on that day, which will limit the number that will be able to attend. The cost is \$20, and the deadline for signing up is April 15th. Karen Rasmussen will invite attendees to Faribault for next year's Tri-Branch Luncheon, which might be held in the Vintage Ballroom. The ballroom worked well for hosting our recent Tri-Branch events.

The upcoming book sale will be held in the same site as last year. Pat Rice has made the arrangements with Faribault West Mall staff members. There is no longer a supervisor for the sentence-to-serve crew at the county. We will have to find another way to move our books, possibly individuals who have community service requirements at the county or students from Shattuck. Sorters, two at a time, are needed to sort books stored at the Congregational Parish House. Pat and Mary Lilllquist will be sorting tomorrow. Books may be dropped off at the mall, beginning on April 6th. Dorothy Joy is managing the work-assignment sheet for the sale. The sign-up sheet will hopefully be published in the March newsletter. Pat Fuchs continues to seek a recycler for unsold books. She has a solid lead with a Northfield recycler, but agreement on price has to be reached. We would not need to pull covers from books with this provider. She has had contact with two other recyclers, but they require covers to be pulled.

Kathy Larson will be making two to three book sale advertising sandwich boards. She has also arranged for us to borrow book shelves again. We will need to pick them up. Pauline Schreiber expressed the need to have guidelines for sorting books into classifications. We will try to have a picture of children looking at our books for sale, sorting books, our AAUW book bags, and/or the grocery cart for donating books put in the Daily News for advertising purposes. Pat Rice has a list of individuals responsible for pre-sales duties. Assignments were also made at the book sale committee's first meeting. Gloria Olson has purchased the bags for our bag-sale event. Letters will be sent to usual repeat customers. We will attempt to compile an email list so we do not have to send as many paper notices next year. This can be done at the sales table during the book sale.

Discussion was held regarding appropriate ways to commemorate our 90th anniversary. Barb Dubbels and Betty Harmsen have been looking into possibilities, including purchasing a commemorative cup or pin. Pat Rice said she would prefer to see a tree be planted, such as at Central Park, to be planted prior to our May meeting possibly on Arbor Day. We could have a short

memorial at the park before the picnic to commemorate, remember and honor those who have served our branch. Board members present today expressed support for the tree idea. We have \$100 budgeted toward the commemoration. We would like to be able to look at branch scrapbook(s) during the May meeting. Cyndy Harrison has offered to do a DVD of the decades since our branch creation. The Historical Society has our archives. This would require a lot of research. No decision has been made. Pauline volunteered to serve on a research committee. Other names suggested were Kathy Kasten, Pat Umbreit, Barb Dubbels and Betty Harmsen. Pat and Kathy reminded us that both GROWS and Friends of the Library found their origins in our local branch.

For Women's History Month in March, articles are being submitted to the Faribault Daily News about women in Minnesota in the 1920's, or what was happening when Faribault was forming our AAUW Branch ninety years ago.

Our members continue to seek empowerment to women. Pat Rice intends to write a letter to actor Patricia Arquette thanking her for her support of equal rights/pay for women in her Oscar acceptance speech at the Academy Awards. Emily Nesvold intends to write to the University of Minnesota, Duluth, regarding their recent termination of the women's hockey coach.

It is the board's responsibility to come up with nominees for offices to be voted on at our May meeting. Board members considered various members to ask for filling the offices of co-president, co-program chair, co-membership chair, and secretary. The co-presidents will call the suggested people and others to see if they are willing to serve. We do not wish to pressure anyone.

Kathy Larson invited board members to attend a Table Tour, to be held at the American Legion, 11 to 2, Sunday, April 19th. Our table will be celebrating the 90th anniversary of our branch. Proceeds will go to the Hope Center. Please get back to Kathy to let her know if you are able to attend.

Pat Rice shared that the American Legion Auxiliary Luncheon is March 28th. Tickets may be purchased from May Bottke.

Kathy Kasten, Educational Equity – Women's Issues

Each year in March, members of the local branch of the American Association of University Women write columns in the Daily News to honor Women's History Month. This year, in honor of the *90th anniversary* of the founding of our Faribault branch, we are choosing to write about Minnesota women who were making news *90* years ago in the 1920s.

Thoughts of the 1920s may bring to mind "Roaring '20s" and flappers, liberation and even decadence. World War I had ended and women had just been given the right to vote. Much else was happening in that era: In 1925, The New Yorker was first published, Sears Roebuck opened its first retail store, the Chrysler Corporation was founded, masking tape was invented in St. Paul, and the first motel opened in San Luis Obispo, California. Though most women were staying at home, keeping house and raising children, many were appearing on the public scene. Nationally Alice Paul led the campaign for an equal rights amendment. Jeanette Rankin, the first woman elected to Congress, was quoted as saying, "I may be the first woman elected to Congress, but I won't be the last." Margaret Sanger led the movement to legalize birth control and founded the predecessor of Planned Parenthood. Georgia O'Keefe became an acclaimed artist. The first female governors were elected in 1925 in Wyoming and in Texas (27 states have elected women since that time, 19 of which have been since 2000). In Minnesota, women also gained prominence. Gratia Alta Countryman, called the "first lady of Minneapolis," was a nationally-known librarian who led the Minneapolis Public Library from 1904 to 1936. She oversaw the building of 12 branches and added more than 500,000 volumes to their stacks. Rhoda Jane Dickinson, ordained in 1921 by the Congregational Church, was likely the first female ordained minister in Minnesota. Marjorie Stoneman Douglas gained acclaim as a journalist, Maude Kegg was a noted Native American beadwork artist and June Marlowe had become a silent film star. By the 1920s, women were earning 39 percent of college degrees.

Faribault university-educated women were looking to become a more purposeful community resource. Thirty-two women joined together in 1925 to found the Faribault branch of American Association of University Women, a national organization founded in 1881. At its organizing meeting in the Faribault Tea Rooms at 203 N. Central, Ella Hutchinson (known then as Mrs. R. R. Hutchinson) became the first

president.

In its 90-year history, Faribault AAUW has been the driving force in many endeavors. Since 1934 it has sponsored public forums for citizens to meet and question political candidates, a project that continues today under the name of "Meet the Candidates." In 1959, Faribault AAUW founded the local Friends of the Library, an organization that continues to be a vital supporter of library events. Since 1971, the branch has conducted a Used Book Sale, which encourages reading and recycling of books through resale and through eco-friendly disposal. Since 1989 AAUW has awarded over 35 college scholarships to local women.

As we celebrate our *90th anniversary* and *Women's History Month*, we will share four weeks of stories about influential Minnesota women in the 1920s. Learn about New Ulm native Wanda Gág, author and illustrator; Lena O. Smith, the first black female attorney in Minnesota; Sister Elizabeth Kenny, who came from Australia to Minnesota to practice the polio treatment she had developed; and Marjorie Child, who developed Betty Crocker for General Mills.

Kathy Kasten is a member of the AAUW and a Faribault resident.
