Secretary's Report

The Faribault Branch of AAUW met at 5:30 pm Thursday, Oct. 10, 2024 in the Faribault City Hall Public Meeting Room. President Mary Niermann convened the meeting. She first asked if there were any corrections or additions to the September minutes printed in the emailed newsletter. Karen Rasmussen said that the gift card Carmen Tripp received from Kwik Trip to help with the Halloween Breakfast was for \$100 rather than \$50, and a Thrivent gift card was used to pay for the-

printing of the tickets. Also, the Christmas party is on Monday, Dec. 16 not Nov. 16. With those correc-

tions, Niermann pronounced the minutes approved as printed in the newsletter. The Treasurer's Report was also printed in the newsletter. Hearing no corrections or additions, Niermann pronounced the report approved as printed in the newsletter.

Signature Card Charge

Rasmussen, treasurer, said the signature card on Faribault AAUW's bank account needs to be changed. Halloween Breakfast Recap by the Numbers:

220 tickets were presale at \$18 for \$3960.

55 tickets were sold at the door for \$1100.

With donations, tips, and selling muffins and milk (\$441), we grossed \$5501.

250 adults (no kids' tickets) were served (about 70 less than the previous two years).

25 people paid \$18 and were no-shows, \$450 for us.

We need to tweak the bill with the Legion....we should net about \$3000.

Thanks to all who sold tickets, paid for tickets, Gail for helping to distribute tickets, Barb for the printing of the tickets, all who came to work and those who came to eat, Kathy, Liz and Tom for the signs that were posted that day, Kathy for sharing her Halloween decorations, those who put up flyers, Judy for getting a Thrivent card to pay for muffins, Karen's Thrivent card paid for the placemats, napkins, coffee creamers, and a twiddlebit of the ticket printing, Carmen who asked for \$100 in product from Kwik Trip and the request was honored so she picked up 61 individually wrapped muffins, 3 gallons of orange juice and 1 gallon of milk, and all those who brought bags of candy. *Karen Rasmussen, Breakfast Co-Chair*

O'Loughlin, met on October
28, at the Rice County
Historical Society, for a
workshop on Legacy Letters.
Margie explains "legacy
writing as "a way to tell a
story to someone you care
about—and put it in the

form of a letter."

Margie was highly qualified to guide our workshop as she has worked for several Minneapolis and St. Paul community newspapers as a freelance writer and photographer (800+articles published). In addition, she offered creative writing classes to groups of older adults across the Twin Cities for years. Classes include memoir writing, writing from prompts, writing through the decades, and writing through the lens of gratitude."

This workshop was set up after Margie contracted COVID and was unable to speak at our September Branch meeting.

The purpose of the workshop was to reflect upon the upcoming 100th anniversary of our Faribault AAUW Branch and to use some of Margie's questions, below, to write our personal legacy letters to our Branch.
